Pursuant to the Stipulation and Order entered July 5, 2012, the Court has reviewed in camera the redacted and unredacted copies of the Hale Written Investigation Report.

Having considered Government Code sections 6254 (c) and 6255 (a) and the instruction of the Court of Appeal in *BRV, Inc. v. Superior Court* (2006) 143 Cal.App.4<sup>th</sup> 742, 755-760, the court finds that the redacted written report is subject to disclosure under the California Public Records Act [Gov. Code section 6250 et. seq.] for the following reasons:

- 1. Mr. Hale is a public official, the former Public Works Director for the City of Rio

1 Dell.

2 2. Mr. Hale has a significant privacy interest in his personnel file, including the Hale  
3 Written Investigation Report.

4 3. As a public official in his position, however, Mr. Hale has a reduced expectation  
5 of privacy in the matters of his public employment.

6 4. The public has a significant interest in the conduct of the Public Works Director in  
7 the performance of his duties.

8 5. The public also has a significant interest in knowing how the officials of the City  
9 of Rio Dell conduct the business of the City, and respond to allegations of misconduct  
10 committed by the Public Works Director.

11 6. Given the circumstances, the public's interest in judging how the officials of the  
12 City of Rio Dell addressed this matter outweighs the potential harm to the privacy  
13 interests of Mr. Hale resulting from the disclosure of the Hale Written Investigation  
14 Report.

15 **ORDER**

16 The Court orders that the City of Rio Dell release to petitioners the redacted Hale  
17 Written Investigative Report. The Court finds that knowing the identities of the persons  
18 making an allegation pursuant to the City of Rio Dell whistleblower policy and all  
19 persons interviewed during the course of preparing the report will not assist the public in  
20 understanding how the officials of the City of Rio Dell responded to the allegations  
21 involving Mr. Hale.

22 The Court further orders that the redacted and unredacted copies of the Hale  
23 Written Investigative Report submitted to the Court be sealed, remain part of the Court's  
24 file herein and remain sealed until further order of the court.
